Dial-A-Law is also available in Chinese and Punjabi.

A complete set of transcripts is available in a three-ring binder with index and tabbed dividers for \$150. Price includes shipping, handling and a one-year subscription of updated scripts that are mailed out twice a year in January and July. Keep your binder updated after your one-year subscription expires by taking advantage of a one-year script update subscription for only \$60. Notification will be mailed two months prior to expiry date.
