Law Societies regulate the conduct of individuals primarily through codes of professional conduct and discipline mostly arising from complaints. Many consider that this complaint-driven retrospective punitive focus on individual conduct should be supplemented by requiring proper policies and practices for law firms.

Gavin Hume (Federation of Law Societies) will chair a panel of leading legal academics presenting on issues relating to the role of lawyers. Leading legal academics Professors **Brent Cotter** (University of Saskatchewan), **Stephen Pitel** (Western University), **Amy Salczyn** (University of Ottawa), and **Sara Seck** (Western University) will present their current work on issues including the duty of loyalty after McKercher, the impact of the UN Guiding Principles on lawyers' advice to clients and the fiduciary law of lawyers.

13:15– 14:45 Legal Ethics/Professionalism in the context of Class Proceedings and Contingent Fees

Law Society codes of professional conduct have been developed in the traditional context of individual clients retaining lawyers for a fair and reasonable fee. Over recent decades, contingent fees in class proceedings and personal injury matters have become an important aspect of access to justice and legal services. Traditional thinking with respect to matters such as the duty of loyalty, confidentiality and privilege, ensuring reasonable fees and the proper roles of the Law Society and the court are not easily applicable in these new contexts.

Stephen Pitel (Western University) will chair a panel of leading experts who will share perspectives from the academy, the bench, the plaintiffs' bar and the defence bar. The panelists are **Michael Eizenga** (Bennett Jones), **Professor Jasminka Kalajdzic** (University of Windsor), **Margaret Waddell** (Paliare Roland) and the **Honourable Warren Winkler** (Arbitration Place).

15:00 – 16:30 Legal Ethics and Access to Justice
