

Vapour intrusion regulations in Canada vary by province but can play a significant role in legal matters pertaining to real estate transactions and redevelopment of contaminated sites. This panel will discuss applicable vapour intrusion regulations and monitoring requirements in Canada, as well as the challenges and emerging solutions to accurately assess vapour intrusion risk and to distinguish between subsurface and background sources. Our expert panel will discuss the challenges associated with background sources, data variability, preferential pathways, acute toxicity and changing regulations. They will discuss new test methods to overcome the challenges and provide more certainty when addressing legal matters.

4:00-5:00 Environmental Insurance – Underwriting Coverage and Claim Disputes | Inspiration Room

Most property and casualty policies exclude pollution risks. This means that environmental insurance policies and riders are often the only coverage that permits recovery of losses from environmental issues or events. These issues and events may involve: (i) historic known and unknown pollution conditions, (ii) spills, leaks and discharges, (iii) environmental impacts from neighbours, and (iv) environmental failures, mishaps and mismanagement. Environmental insurance can serve as a risk transfer tool in any of these contexts including frequently in environmental transactions. Not all coverage is equal and not all insurance products are available from all insurers and for all potential exposures. Notably, environmental coverage is often negotiable with insurers during underwriting. From the claims perspective, there has been judicial consideration of environmental coverage disputes including when coverage triggers and how far coverage extends. Once a claim is issued, there may be further negotiation with one or more insurers about the scope of defence and indemnity coverage which is dependent on the policy language and scope of the plaintiff's claim. Our speakers will touch on key points associated with underwriting environmental coverage, and also environmental defence and indemnity obligations.

8:30-10:15 Updates on the Federal Environmental Assessment Process Review | Inspiration Room

The Minister of Environment and Climate Change established an Expert Panel in August 2016 to review federal environmental assessment processes under the Canadian Environmental Assessment Act, 2012 (CEAA, 2012). The Expert Panel travelled across the country to hear the views and perspectives of Indigenous people and other key stakeholders on how best to reform CEAA, 2012. The Expert Panel submitted its report to the Minister on April 5, 2017. One of the experts on the Panel is Rod Northey. He will provide an overview of the Expert Panel's work and key recommendations.

The Mining Association of Canada (MAC) submitted a detailed brief to the Expert Panel setting out a number of recommendations for it to consider. Justyna Laurie-Lean, Vice President, Environment and Regulatory Affairs will provide MAC's perspective on the reform of CEAA, 2012 and the recommendations of the Expert Panel.

The Environment, Energy and Resources Law Section (NEERLS) and Aboriginal Law Section of the Canadian Bar Association (CBA Sections) also submitted a brief to the Expert Panel suggesting ways to strengthen and improve the federal environmental assessment processes. Tony Crossman, former Chair of NEERLS,

appeared before the Expert Panel to highlight key features of the brief. With the CBA's brief as a backdrop, Tony will also comment on the Expert Panel's report and the public reaction to it.
