Peter Wood, PhD, National Campaign Manager for Environmental Rights with the David Suzuki Foundation, will discuss the growing international movement towards legal recognition of environmental rights, and emerging opportunities to recognize these rights in Canada. In particular, protection of procedural rights regarding the environment has not protected against incursions on environmental rights, particularly with respect to vulnerable populations. Dr. Wood makes the case for a substantive right to a healthy environment being recognized in Canadian legislation, a position shared by the Standing Committee on Environment and Sustainable Development in its June 2017 report regarding the *Canadian Environmental Protection Act*, 1999.

The Honourable Jim Carr, Minister of Natural Resources, will discuss a range of topics surrounding the shifting energy landscape in Canada. This will include discussions on the federal government's proposed Impact Assessment Act, as well as the importance of supporting Indigenous peoples' involvement in resource development. Minister Carr will also speak to Canada's role in the global transition to a low-carbon economy, and the ways in which bolstering the competitiveness of our natural resources will support this transition.

Canadian agriculture and agri-food producers face diverse measures aimed at protecting human, animal or plant life or health. These issues arise in the domestic, international and private supply chain context. At home, new legislation has been introduced under the *Safe Food for Canadians Act*. This complex area highlights the nexus between science, law and policy; the difficulty of distinguishing between valid and trade-restrictive overseas measures; and the challenge of achieving workable and widely-accepted rules. Similar issues face producers for GMOs. This panel will explore possible solutions and provide practitioners with a roadmap to navigating the complexity of these issues.

The Importance of Net Present Valuation of Environmental Liabilities (Trevor Carlson, Geosyntec)

Understanding the financial liability associated with environmental impacts at contaminated sites requires the use of appropriate accounting practices. As remediation projects shift away from reliance on short-term "dig and dump" approaches and toward longer term in-situ remediation or risk management, there is a need to use Net Present value accounting. NPV liability calculations, on long term projects, are often dramatically lower than liability calculations using more simplistic estimation approaches.
